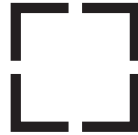

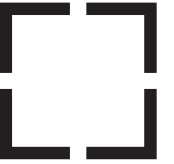

:: Special Notices to Warranty

1. Condensation on the innermost glass surface is the natural result of moisture in the house, and does not indicate a faulty glass unit. Changes in temperature and humidity may create temporary conditions of condensation. While no manufacturer is able to make absolute guarantees implying the total absence of any condensation to approximately zero degrees F outside temperature, with an inside temperature of 70 (seventy) degrees F, and an average relative humidity of 25%.
2. Caulking is required in most installations. Caulking is NOT considered part of the product; therefore it is not covered by this warranty. The only issues that could void this warranty are improper installation, acts of God, misuse or abuse.
3. Oversize windows will not be warranted. Owners requiring or specifying oversized windows do so at their own risk and bear any and all of the aforementioned responsibilities.
4. As of this printing and until further notice, the color of dark brown or "terratone" cannot be warranted against some degree of fading, discoloration or other alterations or changes to the original color. The manufacturer of the compounds currently used in producing the color of dark brown or "terratone" cannot and will not warrant the compounds due to insufficient time periods of testing, and therefore Vinyl Design Corporation cannot and does not make any guarantees related to the color of dark brown or "terratone" and changes thereto.

Vinyl Design Corporation extends the following warranty to the original purchaser of each Vinyl Design Corporation window or patio door. This warranty also extends to all replacement, new construction, and storm products. Under normal use of these products each will be free from defects in material and workmanship. The details of the warranty are as follows:

COLOR COATINGS – 10 YEAR WARRANTY

Color Coatings are guaranteed under normal conditions for a period of ten (10) years, against weathering, specifically, but not limited to, “peeling or blistering and significant ultraviolet discoloration” caused by natural environmental atmospheric conditions. The warranty is void if the damage is caused by an external factor (ex. stucco leach, acidic washes, hard tack tapes, blowing sand, etc.).

GLASS BREAKAGE – LIFETIME WARRANTY

This lifetime warranty, labor and materials, covers up to your residential deductible on your homeowner’s insurance policy.

INSULATING GLASS UNIT – LIFETIME WARRANTY

The insulated glass is warranted against defects in materials and workmanship for as long as you own or reside in the house, which these products were installed. This warranty is against obstruction or vision as a result of film formation or dust collection between the interior glass surfaces, caused by failure of the hermetic seal.

MINI-BLINDS - 10 YEAR WARRANTY

Mini-Blinds between the glass are warranted against defects in materials and workmanship for ten years.

WINDOW OR DOOR UNIT – LIFETIME WARRANTY

These vinyl window and patio doors are warranted against defects in materials and workmanship for as long as you own or reside in the house, which these products were installed.

GENERAL PROVISIONS

Under the terms of this limited warranty, Vinyl Design Corporation agrees to provide components for replacement of any parts that are determined to be defective during the warranty period. These hardware components are warranted against breaking, cracking, or otherwise failing; this provides a lifetime warranty, which is transferable. These components will be furnished to the place of business of the nearest authorized installer. The manufacturer’s obligation under this warranty is limited to furnishing replacement material and does not cover any possible labor charges.

This warranty does not include material that requires replacement, because of mishandling, misuse, abuse, accidents, fire, acts of nature, chemical pollutants in the atmosphere, improper installation or as a result of localized heat that causes

excessive temperature differential over the glass surfaces or edges. Small marks, scratches, and spots, which do not exceed our company standards, do not make insulating glass units defective.

The welded corners of the PVC frames and sashes will never separate. The extrusions will not chip, blister, delaminate, peel, fade, or crack. These frames and sashes have a lifetime warranty, which is transferable.

Condensation of any window or door is the natural result of excessive moisture in the house and changes in interior or exterior temperatures. It does not indicate a defective window or installation. It is even possible for frost to appear on a window as a result of excessive condensation in cold weather. This warranty does not cover condensation, frost, or freezing from condensation on windows. No window can present condensation if the humidity level in the home is too high.

Any such repair or replacement, but the remaining warranty time period shall continue in effect and be applicable under the terms and conditions of this warranty to this repair component of the window, shall not extend the original warranty period.

Transfer of warranty must be expressed in writing by original purchaser and send via certified mail to: VINYL DESIGN CORP., 7856 HILL AVE HOLLAND, OH 43528 within 30 days of property transfer. The remaining warranty will then be effective. This warranty does not include torn screening. The manufacturer reserves the right to discontinue or change any replacement vinyl window or patio door manufactured.

REPAIR OR REPLACEMENT (IN WHOLE OR IN PART) UNDER THIS WARRANTY IS THE EXCLUSIVE REMEDY OF THE PURCHASER, VINYL DESIGN CORPORATION SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THEIR VINYL WINDOW AND PATIO DOORS, ANY IMPLIED WARRANTY OF MECHANABILITY OR FITNESS FOR A PARTICULAR PURPOSE ON THE WINDOW AND DOORS IS LIMITED IN DURATION TO THE DURATION OF THIS WARRANTY, GLASS BREAKAGE WARRANTY VALID ON SINGLE FAMILY DWELLINGS ONLY.

Some states do not allow the exclusion or limitation of incidental or consequential damages or allow limitation on how long an implied warranty lasts, so that above exclusion or limitation may not apply to you. This warranty gives you specified legal rights, and you may also have other rights, which vary from state to state. This warranty is validated by having the attached REGISTRATION CERTIFICATE signed by the original purchaser and the dealer and mailing to VINYL DESIGN CORPORATION within 30 days from the completed installation, inquires should be mailed to VINYL DESIGN CORPORATION, 7856 HILL AVE., HOLLAND, OH 43528.
